Organization Ownership:

- Identify key clinical and non-clinical personnel across the organization to support implementation
- Finalize the enterprise strategy and program design
- Train key organization-level personnel on the DPNCheck device and Reporter software
- Identify key performance indicators (KPI's) to measure implementation efforts
- Define progress reports for executive leadership on clinic deployment efforts

Project Milestones:

- Finalize deployment phases
- Enterprise communication(s):
 - > Introduce the DPNCheck partnership and DPNCheck device
 - > Communicate training & implementation plans to clinic sites
 - Educate the provider community
- Share DPNCheck program implementation plan with participating clinics
- Order and distribute DPNCheck devices
- Complete provider education and staff training

Documenting & Reporting:

- Define the patient screening process before rolling out to providers and staff
- Distribute DPNCheck Reporter software installation and configuration guidelines
- Establish internal coding and risk adjustment procedures
- Finalize program measures and reporting for patient outcomes

Business Optimization:

- Define clinic reordering guidelines
- Refine system-level and clinic-level reporting as program evolves
- Establish frequency of regular business reviews
- Continuous process improvement
